OFT's Construction Bid Rigging Decision: Summary of Infringement Findings

The following table lists the 199 infringements included in the OFT's decision of 21 September 2009, setting out the date of the tender, the name of the tender, the parties involved in the infringement and the approximate value of the winning bid. The table also explains how many of the bids received by the client were from firms involved in the illegal conduct.

In each case involving cover pricing, the party named first supplied a 'cover price' to the other party or parties named. This cover price was an artificially high bid, which was submitted by the latter party(ies) to give the appearance of competition, rather than with the aim of winning the contract.

It can be seen from the final column that the nature of the infringements ranged from tenders where only a minority of bidders engaged in cover pricing, to 11 tendering rounds where every bid received by the client was affected by cover pricing and only one bidding party actually wanted to win. In 43 per cent of tenders, the winning bidder (identified with an asterisk) was involved in collusion with one or more competitors.

Whether or not all bidders were involved in collusion, and whether or not the winning bid came from a colluding party, in all cases competition was distorted. Cover pricing left clients unaware that not all the bids they had received were genuine. As a result, they were unable to make an informed decision as to whether to seek replacement bidders, who may have been cheaper. Because of this, opportunities for other competitors to win the work may also have been reduced. Finally, clients were given a misleading impression of the level of competition available, leading at least potentially to other tender processes being impaired.

Each party has been fined for a maximum of three infringements. Those firms that are named in connection with more than three infringements assisted the OFT under its leniency programme, by providing evidence in respect of a larger number of infringements, and received a reduction in their penalty as set out in the announcement of 22 September 2009.
