Ministerial Foreword

Minimising regulatory burdens and creating the conditions for businesses to flourish are priorities for this Government. That is why I am delighted that, in 2013, DCLG are delivering a net saving to business of over £65 million per year. With this Statement of New Regulation my Department continues to have the largest annual saving to business of any Government department.

In the Sixth Statement of New Regulation, my Department is bringing in three necessary regulatory measures with a combined estimated cost to business of £9.51 million per year. These include a measure to promote earlier and more effective engagement with local communities in the onshore wind turbine industry, the need for which was highlighted in the Government's response to the findings of DECC's call for evidence on the onshore wind industry.

My Department is also bringing in deregulatory reforms which will enable the swifter roll out of 4G mobile telecommunication coverage and speed up planning appeals procedures, making the process more transparent and consistent. We are in the process of having the savings to business of these policies validated by the Regulatory Policy Committee, and expect to publish these in the next Statement.

Since the publication of the Fifth Statement of New Regulation, a number of measures which did not have a validated saving to business have now received a formal Regulatory Policy Committee opinion. Therefore, the essential regulatory measures planned in the Sixth Statement of New Regulation still leave us far exceeding the Government's One-In, Two-Out commitment of delivering double the savings to business for any new regulation.

However, our efforts to make life easier for businesses will not stop here. By the end of this year, we will announce the regulations we will be consolidating, improving and removing following the Planning Administration theme of the Red Tape Challenge. With this, DCLG continue to deliver on the Government's aim to make the UK the best place in Europe to start, finance and grow a business.
